Consent Form

The 29th tRNA Conference Organizing Committee was established at the Department of Chemistry and Biotechnology, Graduate School of Engineering, University of Tokyo (7-3-1 Hongo, Bunkyo-ku, Tokyo 113-8656, Japan) to improve the management and academic results of the 29th tRNA Conference.

The purpose of this privacy notice is to inform participants that the 29th tRNA Conference Organizing Committee will collect, access, use and process participants' personal data in the manner described below, and to request their consent to this processing.

Please read the following carefully and, if you consent, tick the checkbox at the bottom of the form.

1. Explicit consent

As per the General Data Protection Regulation (Article 9(1) and (2)), we require your explicit consent for access and use of the following sensitive personal data:

Information on allergies, dietary requirements or other relevant health information

Your Sensitive Personal Data will be processed in order to fulfil our and your legitimate interests (Article 6(1)(f) GDPR) and for the provision to you of the following services:

- Making accommodation or hotel arrangements
- Making transportation arrangements

- Making other services arrangements
- Supporting you with the tours or with preparations for the tours
- Managing the itinerary or the preparation of the itinerary

Furthermore, participants' personal data will be converted into a form that does not allow individual participants to be identified, and will be used for conference management and statistical purposes.

The 29th tRNA Conference Organizing Committee will manage the conference in order to achieve its operational objectives and to ensure that participants will benefit from participation, so that participants can enjoy the significance of their participation. To do so, we will acquire the minimum amount of personal information necessary.

The 29th tRNA Conference Organizing Committee may retain your personal information for a certain period of time after the conference ends, from the preparation period to as long as there is a legal need to do so, such as accounting for the conference.

In addition, the 29th tRNA Conference Organizing Committee may share participants' personal data with the conference's management company and other companies that provide services to participants, such as hotels, restaurants, transportation providers, travel agencies, etc. within and outside the EEA. Additionally, if your company is located outside the EEA, we will transfer your personal data on appropriate legal grounds based on company regulations and social compliance.

2. Your rights

As a customer you have a number of rights among them: the right to withdraw your consent, to request access to your personal data, to have it corrected or deleted, and the right to object to our processing of your personal data. Privacy policy

① We will ensure that everyone concerned is aware of the protection of personal information, and the chairman and all staff will comply with this. ③ We will implement thorough technical and rational measures to prevent unauthorized access, loss, leakage, falsification, etc. of all personal information handled by 29th tRNA Conference. We will also conduct regular verification of these.

④ We will communicate clearly the contact point for complaints, consultation, etc. regarding the protection of personal information, and will respond sincerely and promptly to requests from individuals.
